FROM OEN PICNIC: Members are requested to monitor 3980 durring a disaster for possible traffic. If there is no net control, plese assume net control until one comes along, we are to try to locate a regular O.E.N. net control to take over the net. --- My thoughts on using two meters in an emergency situation. Most repeaters are toned, and if you do not have the tone, they will be of little use to you if you find yourself mobil and in an emergency situation. When scanning you may locate a repeater but You will not have to time to put in a tone. I would suggest that you use simplex on the repeater output if you do not have the code to bring it up. Most likely some one will hear you. Personally, I moniter 146.52 simplex for emergency traffic. I quit monintering our local repeaters once they were made tone actuated. (ed)

The meeting was called to order by the chairman KA7FHA at 11 am PDT in Crooked River Ranch (Terrebonne) Oregon.

Board Members Present: K7RFO, KA7FHA, KD7HB, WA7FIV and AG7K

The meeting was open to the public to observe and was attended by about 15 members and a few nonmembers. The minutes from 2015 were read and accepted.

ND7V reports that the balance as of today is \$948.23. The report was read and accepted.

Old business: Discussed again how to activate the OEN in an emergency. As the OEN is basically self-activated we need to stay cognizant of what is going on in the region. It was again agreed upon that the Net members should tune

to 3.980 in the event of any emergency unfolding in the northwest United States. It was moved, seconded and approved that the Net Manager will develop a simple guideline for the net members on activation procedures and once approved by the board it will be formally adopted and distributed via the website and email to the members. New Business: AG7K brought to the board the idea of changing the picnic day from Sunday to Saturday for all future OEN picnics. He cited numerous requests and comments from members that he has received. The discussion included comments from the members present on the pros and cons. It was moved, seconded and approved by the board to change the picnic day to Saturday while retaining the same 3rd weekend in August format. With no other new business on the agenda, KA7FHA asked the non-board members in attendance if they had anything for the board? Praise, complaints, any issue? Several members commented negatively on taking early check-ins. That led to a thorough discussion of the pros and cons by all present at the meeting. The overwhelming consensus was that early check-ins are perfectly acceptable, as everyone at times will need to check out early. That being said it was unanimous that the early check in procedure as approved by the board a few years ago needs to be changed. After much discussion a motion was crafted and presented to the board for consideration. The motion said that the Net starts at 6 pm sharp with no early check-ins. As the preamble is read there will be no early check-ins accepted until after emergency gear is called. It is hard enough to hear mobiles at times without the earlies covering the mobiles up. If the earlies are on emergency gear it will be fine to check in under emergency gear. No special calls for earlies will be made by the net control.

The motion was made, seconded and voted on by all board members present to drop the early check in from the OEN net process. The motion as passed states:

The Net will start at 6pm. There will be no early check-ins accepted by the NCS before net. Early check-ins will be accepted at emergency power if they are running emergency power. There will be no call for "earlies" during the preamble or any other time during the net.

Motion to adjourn made, seconded, and approved. The meeting ended at 11:54 am PDT

Note 1 (Back ground notes on changing early check-in process from the meeting)

The discussion on earlies developed the idea that the members that really need to check out early will do so the same way they have done for 50 years before we started taking earlies. Most that complained had the same complaints

- 1. Any chatter before net always brings out a drove of people looking for an early check in and wanting anyone they heard to get them in. This was never an issue until we started taking earlies a couple of years ago. The law of unintended consequences seems to apply.
- 2. The earlies that check in and out before the preamble is read bring nothing to the net other than a number to count. They don't hear the traffic listing or announcements and will not be there to take traffic as needed.
- 3. As the number of earlies goes up (especially by the NCS that call for them after emergency gear) it alters the timing to get to the towns on the list in a timely manner. The ones that wait patiently and stick with the net for the hour really get aggravated by this.
- 4. Everyone involved in the discussion at the meeting wanted to be clear that they did not want to BAN the early check-ins, just manage it in the same manner that the OEN used before we liberalized the policy a few years ago. Note 2 OEN Picnic for 2017: Paul and Veta readily agreed to again host the 2017 meeting/picnic. The picnic will be on Saturday, August 19th, 2017 at noon. The business meeting will be held on the same day at 11am

OEN changes early check-in policy to better accommodate everyone needing out early

There is a change in the way the OEN NCS's will handle early check-ins. This new policy is a direct result of the OEN meeting held in Crooked River Ranch on 8/21/2016 The minutes for that meeting are posted on the website w7oen.net

The motion as passed states:

The Net will start at 6pm. There will be no early check-ins accepted by the NCS before the net. Early check-ins will be accepted at "emergency power" if they are running emergency power. There will be no call for "earlies" during the preamble or any other time during the net.

We still want your early check in, just in a more organized manner!

Let's face it. We all need an early check-in at one time or another. Since we switched to a one net per night format with no cutoff at 7pm it means some nights the net goes long. That will mean you might need to check in early and out to go to another net or dinner. Everyone is encouraged to stay for the whole net if you can, but it is unreasonable to expect it from every member every evening.

The simple solution is for people that need an early check-in is to do so at one of the 5 established breaks that occur when late or missed is called. They are evenly spaced, with the first break right at the end of the preamble. The NCS and relays are prepared to copy calls on their scratch sheet at that point so it does not interrupt the flow of the net.

OEN Early Check-in Policy

There are 5 breaks in the net between the reading of the preamble and the call for out of state checkins. Any one of those breaks, where late or missed is called, is the place to check in early. Please use just your call and state that you need to be out. No need to call out "early check-in" and waiting for a response.

Of course, if you are mobile, we will assume you are checking right out as mobile signals are up and down. Mobiles from any state can check in when "Mobiles" are called.

Emergency power stations from any state can check in when "Emergency Gear" is called. If you are checking in under emergency power and need to be out, just state that you need to be out when you check in. That also applies to checking in when your town is called. If you need out just inform the NCS you need to be out as you check in.

Everybody else needing an early in and out please check in/out at the break that best meets your needs. We do not want to miss anybody and certainly don't want anyone to miss their other commitments when the net is running slow.
